Public Awareness and Prevention programs reaches homeless or incarcerated individuals, intravenous drug users, re-entry populations, healthcare providers, case managers, counselors, those who are at risk for HIV/HCV co-infection, and the general public through a variety of workshops, presentations, conferences, health fairs, anti-body testing on site or remotely, advertising campaigns, and other activities. During 2015 the Hep C Connection held 51 presentations for 1,137 participants in jails, re-entry or homeless facilities; tested a total of 2,054 individuals, 46 of whom tested positive for HCV; and distributed materials at health fairs and exhibits attended by a total of 100,000 individuals.

Client-Centered Advocacy, Support and Referral Network (Support Network) which reaches those directly affected by the Hepatitis C virus and their family and/or friends. Psychosocial support and linkage to care is provided through a variety of avenues that include: the toll-free Helpline (567 calls were received in 2015); support groups (3 that meet on a monthly basis at a variety of Colorado locations with 42 people attending); the monthly "Connections" e-newsletter (sent out to 1,365 email addresses); The Hep C Connection website and printed educational materials offered in both English and Spanish. A Facebook account was also created to take advantage of social networking opportunities and to increase the organization's reach to internet audiences.
